1 AN ACT concerning the state capitol; relating to permanent displays and
2 murals; directing the capitol preservation committee to develop and
3 approve plans for a mural honoring the 1st Kansas (Colored) Voluntary
4 Infantry regiment; creating the 1st Kansas (Colored) Voluntary Infantry
5 regiment mural fund; amending K.S.A. 75-2264 and repealing the
6 existing section.

8 *Be it enacted by the Legislature of the State of Kansas:*

9 Section 1. K.S.A. 75-2264 is hereby amended to read as follows: 75-
10 2264. (a) ~~The Kansas state historical society and the department of~~
11 ~~administration~~ *capitol preservation committee* shall develop and approve
12 plans to place a mural in the capitol honoring the 1st Kansas (Colored)
13 Voluntary Infantry regiment pursuant to K.S.A. 75-2269, and amendments
14 thereto.

15 (b) *The secretary of administration is hereby authorized to receive*
16 *moneys from any grants, gifts, contributions or bequests made for the*
17 *purpose of financing the creation and installation of the 1st Kansas*
18 *(Colored) Voluntary Infantry regiment mural and to expend such moneys*
19 *for the purposes for which received. The secretary of administration shall*
20 *remit all moneys so received to the state treasurer in accordance with the*
21 *provisions of K.S.A. 75-4215, and amendments thereto. Upon receipt of*
22 *such remittance, the state treasurer shall deposit the entire amount in the*
23 *state treasury to the credit of the 1st Kansas (Colored) Voluntary Infantry*
24 *regiment mural fund. Except for the costs associated with the preparation*
25 *and submission of the plans under subsection (a), no public funds shall be*
26 *expended for the purpose of financing the creation or installation of the*
27 *mural developed under this section.*

28 (c) *There is hereby established in the state treasury the 1st Kansas*
29 *(Colored) Voluntary Infantry regiment mural fund. Expenditures from the*
30 *fund may be made for the purposes of creating and installing the 1st*
31 *Kansas (Colored) Voluntary Infantry regiment mural and for such other*
32 *purposes as may be specified with regard to any grant, gift, contribution*
33 *or bequest. All such expenditures shall be made upon warrants of the*
34 *director of accounts and reports issued pursuant to vouchers approved by*

1 *the secretary of administration or the secretary's designee.*

2 Sec. 2. K.S.A. 75-2264 is hereby repealed.

3 Sec. 3. This act shall take effect and be in force from and after its

4 publication in the statute book.
