1 AN ACT concerning motor vehicles; relating to distinctive license plates;
2 providing for the Kansas City Chiefs license plate, *the sporting Kansas*
3 *City license plate* ~~and~~*}, the Sedgwick county zoo license plate}, the*
4 *Kansas City royals license plate* ~~and~~*, the Kansas City current license*
5 *plate}* ~~and~~*, the Topeka zoo license plate {and the support the troops*
6 *license plate; amending K.S.A. 2023 Supp. 8-1,141 and repealing*
7 *the existing section}.*

9 *Be it enacted by the Legislature of the State of Kansas:*

10 ~~New~~**{New }**Section 1. (a) On and after January 1, 2025, any owner
11 or lessee of one or more passenger vehicles or trucks registered for a gross
12 weight of 20,000 pounds or less who is a resident of Kansas, upon
13 compliance with the provisions of this section, may be issued one Kansas
14 City Chiefs license plate for each such passenger vehicle or truck. Such
15 license plate shall be issued for the same time as other license plates upon
16 proper registration and payment of the regular license fee as provided in
17 K.S.A. 8-143, and amendments thereto, and the payment to the county
18 treasurer of the logo use royalty payment.

19 (b) The Kansas City Chiefs football club, inc., may authorize the use
20 of the organization's logo to be affixed on license plates as provided by
21 this section. Any motor vehicle owner or lessee shall pay an amount of not
22 less than \$25 nor more than \$100, as determined by the Kansas City
23 Chiefs football club, inc., as a logo use royalty payment for each such
24 license plate to be issued. The logo use royalty payment shall be paid to
25 the county treasurer.

26 (c) Any applicant for a license plate authorized by this section may
27 make application for such license plate not less than 60 days prior to such
28 person's renewal of registration date, on a form prescribed and furnished
29 by the director of vehicles, and any applicant for such license plate shall

1 pay to the county treasurer the logo use royalty payment. Application for
2 registration of a passenger vehicle or truck and issuance of the license
3 plate under this section shall be made by the owner or lessee in a manner
4 prescribed by the director of vehicles upon forms furnished by the director.

5 (d) No registration or license plate issued under this section shall be
6 transferable to any other person.

7 (e) The director of vehicles may transfer a Kansas City Chiefs
8 ~~football club, inc.~~ license plate from a leased vehicle to a purchased
9 vehicle.

10 (f) Renewals of registration under this section shall be made annually,
11 upon payment of the fee prescribed in K.S.A. 8-143, and amendments
12 thereto, and in the manner prescribed in K.S.A. 8-132~~(b)~~, and amendments
13 thereto. No renewal of registration shall be made to any applicant until
14 such applicant provides to the county treasurer the annual royalty payment.
15 If such annual royalty payment is not made to the county treasurer, the
16 applicant shall be required to comply with the provisions of K.S.A. 8-143,
17 and amendments thereto, and return the license plate to the county
18 treasurer of such person's residence.

19 (g) The Kansas City Chiefs football club, inc., with the approval of
20 the director of vehicles, shall design a plate to be issued under the
21 provisions of this section.

22 (h) As a condition of receiving the Kansas City Chiefs license plate
23 and any subsequent registration renewal of such license plate, the applicant
24 shall consent to the division authorizing the division's release of motor
25 vehicle record information, including the applicant's name, address,
26 royalty payment amount, plate number and vehicle type to the Kansas City
27 Chiefs football club, inc., and the state treasurer.

28 (i) Annual Kansas City Chiefs license plate fee payments collected by
29 county treasurers under this section shall be remitted to the state treasurer
30 in accordance with the provisions of K.S.A. 75-4215, and amendments
31 thereto. Upon receipt of each such remittance, the state treasurer shall
32 deposit the entire amount in the state treasury to the credit of the Kansas
33 City Chiefs license plate fund, which is hereby created in the state treasury
34 and shall be administered by the state treasurer. All expenditures from the
35 Kansas City Chiefs license plate fund shall be made in accordance with
36 appropriation acts upon warrants of the director of accounts and reports
37 issued pursuant to vouchers approved by the state treasurer or the state
38 treasurer's designee. Payments from the Kansas City Chiefs license plate
39 fund shall be made on a monthly basis to the Hunt family foundation.

40 **{New }Sec. 2. (a) On and after January 1, 2025, any owner or**
41 **lessee of one or more passenger vehicles or trucks registered for a gross**
42 **weight of 20,000 pounds or less who is a resident of Kansas, upon**
43 **compliance with the provisions of this section, may be issued one**

1 *sporting Kansas City license plate for each such passenger vehicle or*
2 *truck. Such license plate shall be issued for the same time as other*
3 *license plates upon proper registration and payment of the regular*
4 *license fee as provided in K.S.A. 8-143, and amendments thereto, and*

6 *(b) OnGoal, LLC, may authorize the use of the organization's logo*

9 *more than \$100, as determined by OnGoal, LLC, as a logo use royalty*
10 *payment for each such license plate to be issued. The logo use royalty*
11 *payment shall be paid to the county treasurer.*

12 *(c) Any applicant for a license plate authorized by this section may*
13 *make application for such license plate not less than 60 days prior to*
14 *such person's renewal of registration date, on a form prescribed and*
15 *furnished by the director of vehicles, and any applicant for such license*
16 *plate shall pay to the county treasurer the logo use royalty payment.*
17 *Application for registration of a passenger vehicle or truck and issuance*
18 *of the license plate under this section shall be made by the owner or*

3 *treasurer shall deposit the entire amount in the state treasury to the*
4 *credit of the sporting Kansas City license plate fund, which is hereby*
5 *created in the state treasury and shall be administered by the state*
6 *treasurer. All expenditures from the sporting Kansas City license plate*
7 *fund shall be made in accordance with appropriation acts upon*
8 *warrants of the director of accounts and reports issued pursuant to*
9 *vouchers approved by the state treasurer or the state treasurer's*
10 *designee. Payments from the sporting Kansas City license plate fund*
11 *shall be made on a monthly basis to the Kansas City soccer foundation*
12 *in support of the victory project.*

14 *lessee of one or more passenger vehicles or trucks registered for a gross*
15 *weight of 20,000 pounds or less, who is a resident of Kansas, upon*
16 *compliance with the provisions of this section, may be issued one*
17 *Sedgwick county zoo license plate for each such passenger vehicle or*
18 *truck. Such license plate shall be issued for the same time as other*
19 *license plates upon proper registration and payment of the regular*
20 *license fee as provided in K.S.A. 8-143, and amendments thereto, and*
21 *either the payment to the county treasurer of the logo use royalty*
22 *payment or the presentation of the annual logo use authorization*
23 *statement provided for in subsection (b).*

24 (b) *The Sedgwick county zoological society may authorize the use*
25 *of the organization's logo to be affixed on license plates as provided by*
26 *this section. Any motor vehicle owner or lessee may apply annually to*
27 *the Sedgwick county zoological society for use of such logo. Such owner*
28 *or lessee shall pay an amount of not less than \$25 nor more than \$100 to*
29 *the Sedgwick county zoological society as a logo use royalty payment for*
30 *each such license plate to be issued. The logo use royalty payment shall*
31 *be paid to either:*

32 (1) *The Sedgwick county zoological society, which shall issue to the*
33 *motor vehicle owner or lessee, without further charge, a logo use*
34 *authorization statement that shall be presented by the motor vehicle*
35 *owner or lessee at the time of registration; or*

36 (2) *the county treasurer.*

37 (c) *Any applicant for a license plate authorized by this section may*
38 *make application for such license plate not less than 60 days prior to*
39 *such person's renewal of registration date, on a form prescribed and*

15 *presented at the time of registration or sent by the Sedgwick county*
16 *zoological society, or the annual royalty payment is not made to the*
17 *county treasurer, the applicant shall be required to comply with the*
18 *provisions of K.S.A. 8-143, and amendments thereto, and return the*
19 *license plate to the county treasurer of such person's residence.*

20 *(g) The Sedgwick county zoological society shall provide to all*
21 *county treasurers an electronic mail address where applicants can*
22 *contact the Sedgwick county zoological society for information*
23 *concerning the application process or the status of such applicant's*
24 *license plate application.*

25 *(h) The Sedgwick county zoological society, with the approval of the*
26 *director of vehicles, shall design a plate to be issued under the provisions*
27 *of this section.*

28 *(i) As a condition of receiving the Sedgwick county zoo license plate*
29 *and any subsequent registration renewal of such license plate, the*
30 *applicant shall consent to the division authorizing the division's release*
31 *of motor vehicle record information, including the applicant's name,*
32 *address, royalty payment amount, plate number and vehicle type, to the*
33 *Sedgwick county zoological society and the state treasurer.*

34 *(j) The collection and remittance of annual royalty payments by the*
35 *county treasurer shall be subject to the provisions of K.S.A. 8-1,141(h),*
36 *and amendments thereto.*

37 *{New }{Sec. 4. (a) On and after January 1, 2025, any owner or*
38 *lessee of one or more passenger vehicles or trucks registered for a gross*
39 *weight of 20,000 pounds or less who is a resident of Kansas, upon*
40 *compliance with the provisions of this section, may be issued one Kansas*
41 *City royals license plate for each such passenger vehicle or truck. Such*
42 *license plate shall be issued for the same time as other license plates*

38 **payment to the county treasurer of the logo use royalty payment or the**
39 **presentation of the annual logo use authorization statement provided**
40 **for in subsection (b).**

41 **(b) The friends of the Topeka zoo, inc., may authorize the use of**
42 **the organization's logo to be affixed on license plates as provided by**
43 **this section. Any motor vehicle owner or lessee may apply annually to**

1 the friends of the Topeka zoo, inc., for use of such logo. Such owner or
2 lessee shall pay an amount of not less than \$25 nor more than \$100 to
3 the friends of the Topeka zoo, inc., as a logo use royalty payment for
4 each such license plate to be issued. The logo use royalty payment
5 shall be paid to either:

6 (1) The friends of the Topeka zoo, inc., which shall issue to the
7 motor vehicle owner or lessee, without further charge, a logo use
8 authorization statement that shall be presented by the motor vehicle
9 owner or lessee at the time of registration; or

10 (2) the county treasurer.

11 (c) Any applicant for a license plate authorized by this section
12 may make application for such license plate not less than 60 days prior
13 to such person's renewal of registration date, on a form prescribed

36 and return the license plate to the county treasurer of such person's
37 residence.

38 (g) The friends of the Topeka zoo, inc., shall provide to all county
39 treasurers an electronic mail address where applicants can contact the
40 friends of the Topeka zoo, inc., for information concerning the
41 application process or the status of such applicant's license plate
42 application.

43 (h) The friends of the Topeka zoo, inc., with the approval of the

1 director of vehicles, shall design a plate to be issued under the
2 provisions of this section.

3 (i) As a condition of receiving the Topeka zoo license plate and
4 any subsequent registration renewal of such license plate, the
5 applicant shall consent to the division authorizing the division's
6 release of motor vehicle record information, including the applicant's
7 name, address, royalty payment amount, plate number and vehicle
8 type, to the friends of the Topeka zoo, inc., and the state treasurer.

9 (j) The collection and remittance of annual royalty payments by
10 the county treasurer shall be subject to the provisions of K.S.A. 8-
11 1,141(h), and amendments thereto.

12 {New Sec. 7. (a) On and after January 1, 2025, any owner or
13 lessee of one or more passenger vehicles or trucks registered for a
14 gross weight of 20,000 pounds or less, who is a resident of Kansas,
15 upon compliance with the provisions of this section, may be issued one
16 support the troops license plate for each such passenger vehicle or
17 truck. Such license plate shall be issued for the same time as other
18 license plates upon proper registration and payment of the regular
19 license fee as provided in K.S.A. 8-143, and amendments thereto.

20 (b) Any applicant or renewal of registration for a support the troops
21 license plate authorized by this section shall make payment of
22 an annual support the troops fee to the county treasurer of \$25 for
23 each license plate to be issued. Any support the troops fee payment
24 received pursuant to this section shall be used to support the purposes
25 of the Kansas department of the American Legion and the Kansas
26 department of veterans of foreign wars.

27 (c) Any applicant for a license plate authorized by this section
28 may make application for such license plate not less than 60 days prior
29 to such person's renewal of registration date, on a form prescribed
30 and furnished by the director of vehicles. Application for registration
31 of a passenger vehicle or truck and issuance of the license plate under
