The **agency** requests \$202,404, all from the Board of Barbering Fee Fund, in expenditures and 1.9 FTE positions for FY 2025. This is an increase of \$4,505, or 2.3 percent, above the agency's FY 2024 request. The increase is attributable to ongoing vendor expenditures for administering the barbering examination (\$500), gasoline (\$250), and increased travel and lodging expenditures (\$1,450). The increase for testing and gasoline expenditures are to address the issues mentioned in the agency's FY 2023 supplemental requests.
