## Agency Estimate

The **agency** estimates revised expenditures of \$974,702, all from special revenue funds, in expenditures and 6.0 FTE positions in FY 2023. This is an increase of \$64,282 or 7.1 percent, above the FY 2023 approved amount. The increase includes a supplemental request of \$40,000 to increase the capacity and security of the Central Registry database. The revised estimate also includes an increase of \$22,000 in salaries and wages. The increase of \$10,800 in contractual services is due to leasing an additional 847 square feet of office space, resulting in an increase in annual rent expenditures.

The increase of \$10,800 in contractual services is due to leasing an additional 847 square feet of office space, resulting in an increase in annual rent expenditures.
