Thank you for the opportunity to discuss the Judicial Branch in particular the subject of docket fees.

The unification of trial courts in January of 1977 abolished probate, juvenile, county courts, and magistrate-level courts of county-wide jurisdiction. The jurisdiction of these courts was consolidated into one court - the district court. The 1978 Legislature began phasing in state funding for the cost of nonjudicial personnel in the district courts. This was originally envisioned as a multi-phase process, beginning with personnel costs. In a subsequent phase, the State was to assume the operating costs of the court system. However, to date, only the first phase has been funded. Currently, district court employees are paid by the State and court operating expenses are paid by the counties. This is the reason that 98% of the State General Fund budget is expended on personnel. The judicial branch operating budget pays for the operations of the Judicial Center and for judges to travel to hear cases. Thus, any budget presentation will primarily focus on personnel issues.

Part of the compromise when the state assumed personnel costs was that most of the money generated by the courts would accrue to the State. Courts are not intended to be money-makers; but a significant amount of fees and fines are collected by the district courts for the benefit of the State. The following appendices provide an overview of those fees:

- Appendix A shows those collections for FY 2012.
- Appendix B shows the various docket fees and indicates the county funds that receive a portion of docket fees before the balance is sent to the State Treasurer. The last page of the attachment shows the distribution schedule used by the State Treasurer to deposit Clerks' Fees and Fines into state funds.
- Appendix C provides the estimated revenue to each fund from clerks' fees and fines fees and forfeitures.
- Appendix D sets forth an example of the distribution of the docket fee and fine in a traffic case.

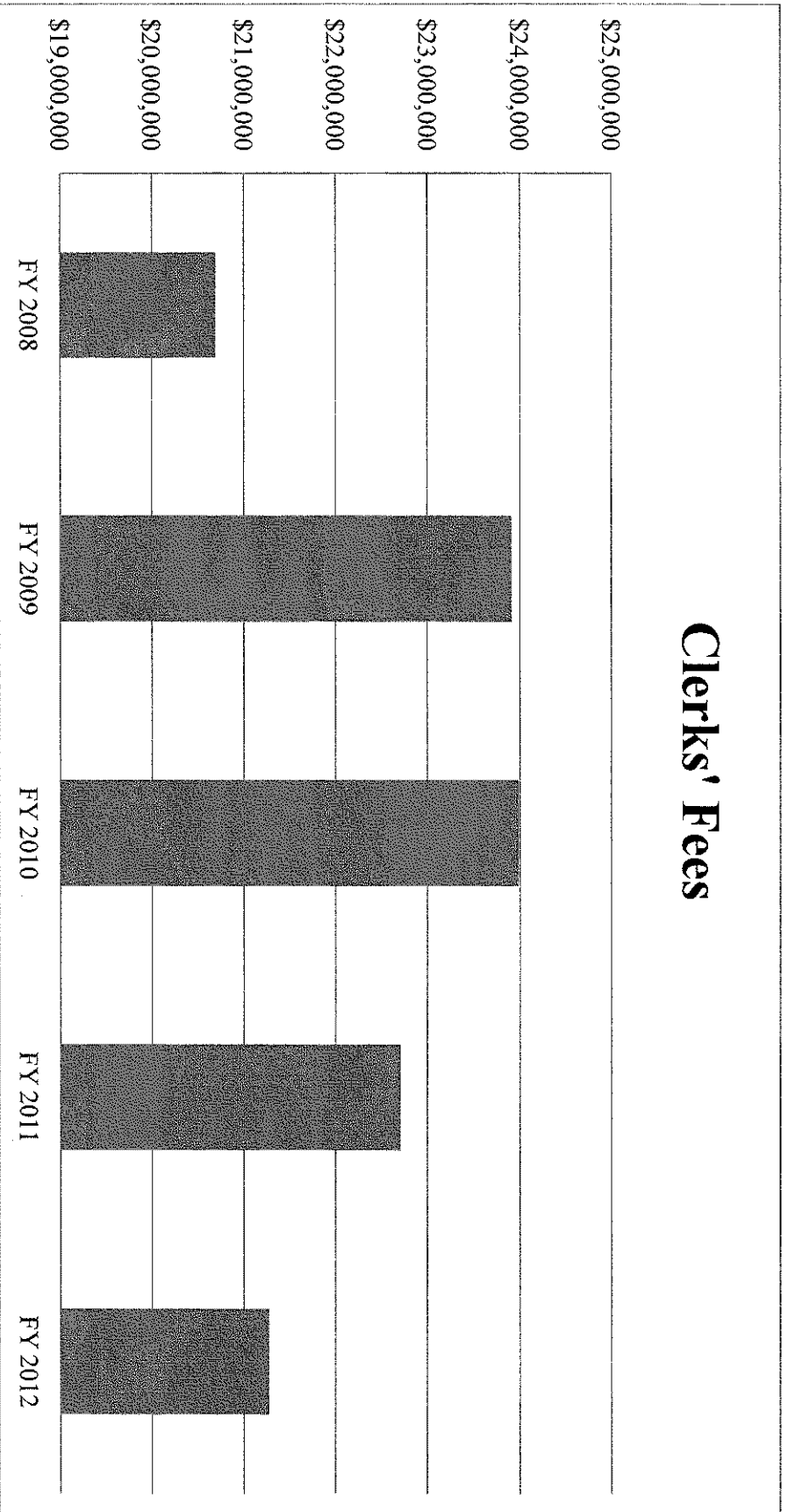
