HB 2013 concerning elections; dealing with write in candidates - Shawnee County Information

Martha,

Per our discussion this afternoon regarding HB 2013 dealing with write-in candidates, the Shawnee County Election Office offers the following experience as requested:

1. Background Information — For the 2016 Primary Election, Shawnee County has twelve (12) townships with two positions each (Trustee and Treasurer) = 24 township offices times two parties (Democratic and Republican) = 48 township races

2. 2016 Primary Election Results:

- A. Background Information For the 2016 Primary Election, Shawnee County has twelve (12) townships with two positions each (Trustee and Treasurer) = 24 township offices times two parties (Democratic and Republican) = 48 township races
- B. Of the 48 township races, eleven (11) were won by write-in votes and one (1) township race didn't have any candidate receive the minimum number of write-in votes to win (K.S.A. 25-213).
- C. Of the 11 township races won by write-in votes, seven (7) accepted their nominations and were placed on the 2016 General Election ballot. Four (4) of the eleven withdrew/declined the nomination as they were four of the previously mentioned seven and won the nomination for office by write-in votes by both parties. They accepted the nomination of their identified party and subsequently withdrew the nomination by the other party per K.S.A. 25-306.
- D. Side Note regarding the one township position that did not have a Primary Election winner due to insufficient number of write-in votes: In the 2016 General Election, this position resulted in two people tied with six (6) write-in votes each. Both candidates were notified by the Shawnee County Election Office prior to the breaking of the tie. The Board of Canvassers drew lots per K.S.A. 25-3108. The winner subsequently declined and the Board of County Commissioners recently filled the position by appointment.

3. 2014 Primary Election Results:

A. One Township Clerk race resulted in the same person winning both the Democratic and Republican nominations by write-in votes from each party. The winner accepted their party nomination and declined the other party's nomination.

Representative Esau,

I have spoken with people from Johnson and Shawnee county election offices. Here is what I have so far:

- Johnson County The office keeps track of all those nominated and elected by write-in; however, the office does not maintain a list of those who have resigned. But three election office staff members conferred on this question and none of the three were aware of any such occurrence (i.e., a write-in resigning immediately after election in November). Given the current Election Commissioner has been in office for only a year (he was out today), these individuals did not think they could do better than the answer they supplied.
- Shawnee County I spoke with Mark Stock, who said the following:
 - o He knows for certain of one such case in the 2016 election. He will email me the details.
 - o He will look for others and let me know if he finds them.

I have not called Reno County yet; I will try to do so before my 1:30 meeting.
