| 35 | (b) The director of accounts and reports shall secure prior to the |
| 36 | payment of any amount to any claimant, other than amounts authorized to |
| 37 | be paid pursuant to section 7, and amendments thereto, as motor-vehicle |
| 38 | fuel tax refunds or as transactions between state agencies as provided by |
| 39 | this act, a written release and satisfaction of all claims and rights against |
| 40 | the state of Kansas and any agencies, officers and employees of the state of |
| 41 | Kansas regarding their respective claims. |
| 42 | Sec. 9. This act shall take effect and be in force from and after its |
| 43 | publication in the Kansas register. |
