Re: HB 2601

Dear Education Committee Members,

I am writing to you to ask you to support Representative Huebert's bill HB 2601 (school immunizations). My points are as follows:

1. The KDHE has violated procedures and mandated vaccines that are not even transmissible in a school environment.
2. The KDHE is funded by pharma and therefore should never be allowed to mandate vaccines. Their ties to Immunize Kansas Coalition also make their actions suspect.
3. Where there is risk, there must be choice. Mandating people to inject something with known risks and poor safety studies into their bodies is unconscionable.
4. I have 4 unvaccinated and incredibly healthy kids from 4-23 that do NOT have recurring ear infections, allergies of any kind, eczema, ADD/ADHD, autism or any spectrum disorder, type 1 diabetes, or any other autoimmune disorder.

Point 1: In 2019 the KDHE violated procedure and tried to sneak the meningitis and hepatitis A vaccines onto the mandated school schedule. They were caught but ended up adding them anyway after much protest. Imagine this, a child that actually has hepatitis A can attend school, but a child that does not have the vaccine and also does not have hepatitis A cannot. Hepatitis A is not even transmissible in a school setting! This is how I know it is not about health but about padding pharma's pockets. This is how I know the KDHE is CORRUPT.

Point 2: The KDHE is funded by pharma. They have deep ties to and are heavily influenced by the Immunize Kansas Coalition, who are also funded by pharma. It's unbelievable that we would allow them any say in vaccination mandates. Again, the KDHE is CORRUPT.

Point 3: Vaccines each have a long list of adverse reactions listed on the insert. Although you have heard 'they are safe and effective' ad nauseam, no vaccine has ever been tested with an INERT placebo, the gold standard of clinical trials. Many vaccines contain human DNA. The CDC knows it's dangerous so it limits the amount a vaccine can contain. However, no vaccine has ever met that number and they contain trillions of DNA fragments including the whole genome of the MRC-5 child. What might that cause? Autoimmune diseases? Gender confusion? The truth is, we don't know because the studies have never been done. Where there is RISK, there must be CHOICE.

Point 4: I am one of the lucky ones. I didn't vaccinate my kids (except one kid had the tetanus vaccine before I understood and knew better. He's by far my sickest kid). They are not injured and their immune systems are intact. Therefore they are vibrant and healthy, rarely sick and recover easily when they are. I fear we've forgotten what healthy kids look like now that 1 in 2 have some debilitating allergy, illness, or disease. Do you remember when nobody had allergies and autoimmune diseases? I do.

Thank-you for considering this matter. I urge you to protect the kids in Kansas by taking the power to mandate vaccinations away from the corrupt KDHE. We are watching. We are mobilizing. We are educating. We are voting.
