The Committee held action on SB 368, recommending the bill favorably for passage.)		SB 368 is on General Orders in the Senate and similarly, it addresses the transfer of \$268.4 million from the SGF to pay off delayed employer contributions (FY 2017 and FY 2019), while eliminating the current repayment plans over 20 years.)
