## HOUSE BILL No. 2695

AN ACT concerning law enforcement; relating to the commission on 1 2 peace officers' standards and training; Kansas law enforcement training 3 act; definitions; lapsing certification; amending K.S.A. 74-5602 and 4 repealing the existing section. 5 6 *Be it enacted by the Legislature of the State of Kansas:* 7 New Section 1. The secretary of corrections may, with the consent of the director of police training, designate an employee of the department 8 other than a special agent, to attend the law enforcement training center or 9 10 any training school certified pursuant to K.S.A. 74-5604a, and 11 amendments thereto, or to attend courses provided by the training center or 12 training schools. The employee and the department of corrections shall be 13 provided a transcript of the courses successfully completed by the 14 employee. 15 Sec. 2. K.S.A. 74-5602 is hereby amended to read as follows: 74-16 5602. As used in the Kansas law enforcement training act: "Training center" means the law enforcement training center 17 (a) 18 within the university of Kansas, created by K.S.A. 74-5603, and 19 amendments thereto. 20 (b) "Commission" means the Kansas commission on peace officers' 21 standards and training, created by K.S.A. 74-5606, and amendments 22 thereto, or the commission's designee. 23 (c) "Chancellor" means the chancellor of the university of Kansas, or 24 the chancellor's designee. 25 (d) "Director of police training" means the director of police training 26 at the law enforcement training center. 27 (e) "Director" means the executive director of the Kansas commission 28 on peace officers' standards and training. 29 (f) "Law enforcement" means the prevention or detection of crime 30 and the enforcement of the criminal or traffic laws of this state or of any 31 municipality thereof. 32 "Police officer" or "law enforcement officer" means a full-time or (g) 33 part-time salaried officer or employee of the state, a county or a city, 34 whose duties include the prevention or detection of crime and the 35 enforcement of the criminal or traffic laws of this state or of any 36 municipality thereof. Such terms shall include, but not be limited to: The

sheriff, undersheriff and full-time or part-time salaried deputies in the 1 2 sheriff's office in each county; deputy sheriffs deputized pursuant to 3 K.S.A. 19-2858, and amendments thereto; conservation officers of the 4 Kansas department of wildlife, parks and tourism; university police officers, as defined in K.S.A. 22-2401a, and amendments thereto; campus 5 6 police officers, as defined in K.S.A. 22-2401a, and amendments thereto; 7 law enforcement agents of the director of alcoholic beverage control; law 8 enforcement agents designated by the secretary of revenue pursuant to 9 K.S.A. 2019 Supp. 75-5157, and amendments thereto; law enforcement 10 agents of the Kansas lottery; law enforcement agents of the Kansas racing commission; deputies and assistants of the state fire marshal having law 11 12 enforcement authority; capitol police, existing under the authority of 13 K.S.A. 75-4503, and amendments thereto; special investigators of the juvenile justice authority; special agents of the department of corrections; 14 15 special investigators designated by the secretary of labor; and law enforcement officers appointed by the adjutant general pursuant to K.S.A. 16 17 48-204, and amendments thereto. Such terms shall also include railroad 18 policemen appointed pursuant to K.S.A. 66-524, and amendments thereto; 19 school security officers designated as school law enforcement officers 20 pursuant to K.S.A. 72-6146, and amendments thereto; the manager and 21 employees of the horsethief reservoir benefit district pursuant to K.S.A. 22 2019 Supp. 82a-2212, and amendments thereto; and the director of the 23 Kansas commission on peace officers' standards and training and any other 24 employee of such commission designated by the director pursuant to 25 K.S.A. 74-5603, and amendments thereto, as a law enforcement officer. Such terms shall not include any elected official, other than a sheriff, 26 27 serving in the capacity of a law enforcement or police officer solely by 28 virtue of such official's elected position; any attorney-at-law having 29 responsibility for law enforcement and discharging such responsibility 30 solely in the capacity of an attorney; any employee of the commissioner of 31 juvenile justice who is employed solely to perform correctional, 32 administrative or operational duties related to juvenile correctional 33 facilities; any employee of the secretary of corrections; other than a 34 special agent; any employee of the secretary for children and families; any 35 deputy conservation officer of the Kansas department of wildlife, parks 36 and tourism; or any employee of a city or county who is employed solely 37 to perform correctional duties related to jail inmates and the administration 38 and operation of a jail; or any full-time or part-time salaried officer or 39 employee whose duties include the issuance of a citation or notice to 40 appear provided such officer or employee is not vested by law with the 41 authority to make an arrest for violation of the laws of this state or any 42 municipality thereof, and is not authorized to carry firearms when 43 discharging the duties of such person's office or employment. Such term

1 shall include any officer appointed or elected on a provisional basis.

2 (h) "Full-time" means employment requiring at least 1,000 hours of 3 law enforcement related work per year.

4 (i) "Part-time" means employment on a regular schedule or 5 employment which requires a minimum number of hours each payroll 6 period, but in any case requiring less than 1,000 hours of law enforcement 7 related work per year.

8 (j) "Misdemeanor crime of domestic violence" means a violation of 9 domestic battery as provided by K.S.A. 21-3412a, prior to its repeal, or K.S.A. 2019 Supp. 21-5414, and amendments thereto, or any other 10 misdemeanor under federal, municipal or state law that has as an element 11 12 the use or attempted use of physical force, or the threatened use of a deadly weapon, committed against a person with whom the offender is 13 involved or has been involved in a "dating relationship" or is a "family or 14 15 household member" as defined in K.S.A. 2019 Supp. 21-5414, and amendments thereto, at the time of the offense. 16

(k) "Auxiliary personnel" means members of organized nonsalaried
groups who operate as an adjunct to a police or sheriff's department,
including reserve officers, posses and search and rescue groups.

20 (1) "Active law enforcement certificate" means a certificate-which-21 *that* attests to the qualification of a person to perform the duties of a law 22 enforcement officer and-which *that* has not been suspended or revoked by 23 action of the Kansas commission on peace officers' standards and training 24 and has not lapsed by operation of law as provided in K.S.A. 74-5622, and 25 amendments thereto.

Sec. 3. K.S.A. 74-5602 is hereby repealed.
