Re: March 1, 2022 hearing on Senate Bill 389, relating to voting systems and procedures – Opponent testimony, WRITTEN-ONLY testimony from Rick Piepho, representing KCCEOA.

Honorable Kansas State Senator Rob Olson Chair, Senate, Committee on Federal and State Affairs and Distinguished Members of the Committee

My name is Rick Piepho, Harvey County Clerk and Chairman of the Elections Committee of the Kansas County Clerks and Elections Officials Association (KCCEOA). The KCCEOA is a statewide organization with 109 members including 103 publicly elected county clerks, 2 charter appointed county clerks, and additionally, four election officers from the most populous counties in Kansas. Our duties are significant under statute and one of our most public facing functions is free and fair administration of elections. We take this duty very seriously. We prepare for every possible, and impossible, scenario which could occur. Our organization has a legislative platform adopted by the membership. I have attached that platform to this testimony for your use.

I am testifying today in my capacity as elections committee chairman on behalf of the association to object to several provisions of this act. We understand and agree with the intent to build on the already secure election processes in Kansas, but we do not believe that this legislation accomplishes that goal.

We believe that there are multiple issues with this bill that should be considered:

Section 1 (a) (1) (A) we are in need of more guidance as to what would constitute a distinctive watermark. Would the watermark need to be embedded in the fibers of the paper when it is manufactured, or a unique security feature pre-printed on the ballot stock or printed on the ballots or would a unique mark or stamp placed on the ballot by the election office or poll worker qualify? We already have a number of procedures in place along with checks and balances to ensure that fraudulent ballots are not counted. It would be very difficult for ballots cast by federal service (UOCAVA) voters to comply since they are allowed to receive and return their ballots by fax or email. Please give us, and the Secretary, more guidance on this section.

Section 1 (a) (1) (A) (i) of this measure requires ballots to be marked by hand or by <u>non-tabulating</u> voting machines. This would require counties that use direct recording electronic systems (DRE) machines purchase new equipment even if they have a voter-verifiable paper trail. Current law prohibits the purchase of new DRE equipment, but does not require purchasing new election equipment. Most counties have replaced their DRE equipment with non-tabulating ballot marking devices, but some still have not so this would be an unfunded mandate.

Section 1 (a) (4) states that paper ballots shall be hand-counted unless requestor chooses otherwise. KSA 25-3107 specifies that "the method of conducting the recount shall be at the discretion of the

person requesting the recount" so candidates/requestors already have the option to request a recount by hand.

Subsection (b) requires a sample hand-counted audit at the polling place of each precinct. I am not sure this is possible while maintaining ballot secrecy or hand-counting every ballot. Some ballots could be randomly selected and hand counted, but it would be virtually impossible to get a report from tabulator of how those specific ballots were tabulated without numbering or serializing the ballots and scanned images which could make it possible to associate the ballot to a specific voter. Please give us, and the Secretary, more guidance on this section.

Subsection (c) requires a hand-written signature on poll book. We would like clarification to define what is considered a hand-written signature. Does a hand-written signature utilizing a stylus or other device on an electronic device such as an electronic pollbook meet this requirement or does this mean that the signature must be on paper utilizing a pen or other writing implement?

Mr. Chairman, for these reasons, we oppose SB 389 as currently presented and ask that the committee hear our concerns and act accordingly. I will not be able to attend the hearing so we are providing written testimony only on this bill.

## **2022 Legislative Priorities**

The members of the KCCEOA want to bring special focus to the following with regard to elections:

- Encourage legislature to complete redistricting in a timely manner.
- Maintain the status quo with regard to election, registration and canvass schedules and with regard to partisan/non-partisan elections.
- Advocate for protecting the integrity of the anonymous ballot.
- Advocate for measures that allow provisional ballots to be counted for registered voters who moved within the state.
- Advocate for expansion of eligibility requirements for permanent advance voting status while also making requirements more stringent for all permanent election applicants to maintain status.
- Support initiatives which build on already secure and transparent election equipment and processes.
- Advocate for establishing lawful, consistent and workable timelines for special elections.
- Maintain local control of usage and placement of drop boxes for advance ballots.
- Ease pollworker employment restrictions for KPERS and unemployment.

The membership of the KCCEOA reviews, discusses and participates in drafting the Kansas Association of Counties (KAC) annual legislative policy. The members of KCCEOA want to bring special focus to the following with regard to county governance:

- Retain and enhance county home rule authority and maintain local decision making, standing on the principle that government closest to the people will best understand and serve the community's needs.
- Support local control of property taxes.
- Oppose unfunded mandates and support state funding for any current statutory mandates.
- Support allowing choice of alternate sources or methods for distributing official publications, including legal notices.
- Support flexibility to utilize preliminary values when calculating mill levy rates for shared districts.
- Join with other county office holders in opposing deferment of payments to KPERS and the sweeping of funds intended for transportation.
